### **THE ST. JOHN'S 50<sup>TH</sup> ANNIVERSARY THEOLOGICAL EDUCATION FUND**

The St. John's 50<sup>th</sup> Anniversary Theological Education Fund was established by the Church in 1999 on the occasion of its 50<sup>th</sup> Anniversary in gratitude to God for the ministries of those who have served as St. John's Ministers.

#### **ELIGIBILITY FOR GRANT**

Any active member of any particular church of the Presbyterian Church (U.S.A.), or its successor, is eligible to apply for a grant from the St. John's 50<sup>th</sup> Anniversary Theological Education Fund. Individuals applying for a grant must be an Inquirer or Candidate under Care of a presbytery of the Presbyterian Church (U.S.A.) preparing for ordination to the Office of Minister of the Word and Sacrament of the Presbyterian Church (U.S.A.).

#### **PREFERENTIAL CONSIDERATION**

First preference will be given to persons meeting the eligibility criteria who are Active members of St. John's Presbyterian Church of Reno, Nevada, according to the Roll of Active Members kept by the Clerk of Session.

Second preference will be given to persons meeting the eligibility criteria who are Active members of any member congregation of the Presbytery of Nevada of the Presbyterian Church (U.S.A.), or its successor, according to the Roll of Active Members kept by the Clerk of Session of that member congregation.

Third preference will be given equally to proposals from any seminary of the Presbyterian Church (U.S.A.) which will benefit students studying and planning to enter the Ministry of Word and Sacrament of the Presbyterian Church (U.S.A.); and to any person meeting the eligibility criteria who is an Active member of any member congregation of the Presbyterian Church (U.S.A.), or its successor, according to the Roll of Active Members kept by the Clerk of Session of that member congregation.



## **APPLICATION**

Applicants are to address a letter of application to the Chair, Endowment and Restricted Funds Committee; c/o The Clerk of Session; St. John's Church; 1070 West Plumb Lane; Reno NV 89509.

## **GRANT LIMITATION**

No grant to an individual applicant shall be made in excess of the amount equal to tuition for one full academic year by the theological seminary in which the applicant is enrolled. Grants may be used to cover expenses such as tuition, books, rent, clothing, transportation and other costs associated with the student's theological education.
