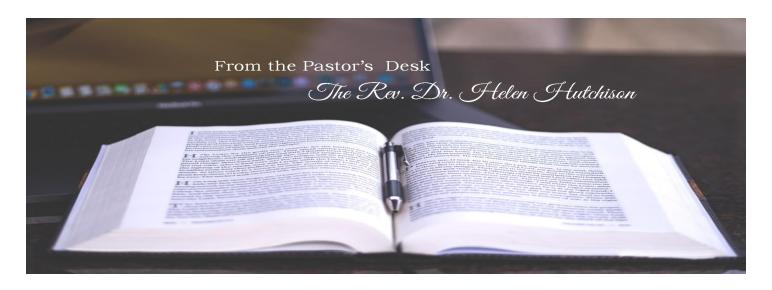

2021 continued to be a time to deal with the Covid pandemic. We were able to return to in person worship, as well as continue worship by Zoom and then this fall switched to a live streaming service. I am grateful to the members, leaders and visitors of St John's have continued to adapt as we have done our best to keep people safe and keep the central part of worship, mission, fellowship, and education available in person and online. I know I am blessed to be working with an incredible staff who remain flexible and work hard to keep everything functioning in our new world. There continue to be restrictions (sometimes) on visiting people who are homebound

or in the hospital, which is difficult. It was a joyful moment when we could return to in person worship, it was wonderful to have an early service outside this spring and summer and then inside this winter. It also is amazing that our streaming service and Zoom classes reach people who are homebound, or at a distance (even in other states). It has been a demanding year.

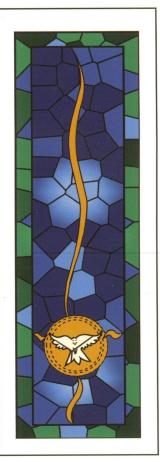

The following are some specific activities for the year:

- As part of the Presbytery, I was Moderator of the Committee on Ministry from September 2020-October 2021.
- Worship at St John's
 - Sunday morning worship is central to St John's and continued to be central through zoom. Maria Winchester ran the technology, David Brock played the organ from home, Paul Torkelson assisted with worship leadership and Molly and Amy Willoughby led us in the hymns.
 - ♦ For Sunday morning worship
 - We started the year following the lectionary readings from the gospel of Mark.
 - ♦ For Lent we continued in Mark and followed Jesus through Holy week beginning with Psalm Sunday Mark 11:1 and going through the Easter Sunday Mark 16.
 - ♦ In the Summer we followed a sermon series on the people in Scripture who had seen God Face to Face.
 - ♦ During the fall we read through the entire book of James.



- ♦ We celebrated special worship services: Ash Wednesday, Maundy Thursday, Good Friday and Christmas Eve. For Lent we had a special devotional time once a week where different congregational members reflected on the objects that are part of Jesus' journey to the cross and experience on the cross.
- This spring we started an early Sunday morning outside service. In the spring and summer, I preached from hymns. We revamped the service this fall to include a mission project once a month, special music once and month and sermons twice a month.
- ◆ This year I had the honor of recognizing God faithful servants who left the earth this year and passed to God's kingdom. In 2021, I officiated at services of Witness to the Resurrection for: Jim Jeffers, Bob Stover, Garrett Scott Lauf, Genie Matthews, Bruce Krater, Ralph Voss, Susan Sherman-Kobza, and Evelyn Wagner.
- We offered several adult study opportunities by Zoom:
 - We had a Tuesday afternoon class that met for most of the year which talked about: What Presbyterians Believe, a Lenten study looking at grace and the musical Les Mis, Resurrection Appearances, Presbyterian Creeds and Confessions.
 - We had a Thursday 11:00 am class which studied the minor prophets, the Parables, the Lord's Prayer, the Apocrypha, the Crusades, the Trinity, a book study of the Lemon tree and looking the current issues in Israel and Palestine.
- I was active in the Women clergy group in Reno.
- I was able to take advantage of a training from the Lombard Mennonite



Thank you again to the congregation and Friends of St John's Presbyterian Church as we made it through another difficult year continuing to worship, study and care for each other.

I am so proud of the way St John's has continued to be God's church in Reno, Nevada.

Then, we have our wonderful, Peggy Meyer who mailed cards to anyone when needed and faithfully sent birth-day cards; we are so happy Peggy continues to work with Deacons.

Two of our members retired, and we gained three new ones. We also lost our beloved Jeanne Robinson to Covid.

We met on Zoom and on our new streaming channel only 9 times this past year because there were 3 months I felt it was not necessary to meet due to a lack of information. We held four memorials this past year: Genie Mathews, Ralph Voss, Bruce Krater, and Mary Ann King; all were well attended.



We did manage to meet outdoors to fill Easter bags for our home-bound members, and we met again in Martin Hall to fill Christmas bags for them. We heard from some of them and they were really pleased with their goodies.

Communion was served prepackaged packets containing cups, juice, and wafer inside. We eventually decided to serve by not only masking up, but also wearing gloves and serving real bread and using regular cups with our own

grape juice. All have responded well and we will continue doing this until we can finally serve the traditional way.

It has been a pleasure to work with the Deacons and hope all of us will continue to serve our congregation to the fullest; please keep us in your prayers so we are able to do God's work among you.

The Building & Grounds Committee

Our committee is tasked with the care of the entire church property and maintenance of all church equipment.

Our meetings are on the first Monday of each month, and we welcome interested members of the church to attend and will always welcome those interested in joining us.

Below are the projects we have accomplished during the 2021 year.

- Removed weeds throughout the Church property during Spring Cleanup.
- Repaired or replaced many of the sprinklers to operate correctly.
- Replaced Barrett Park sprinkler timer.
- Replaced all LED light bulbs in the Sanctuary.
- Added two cameras and control screen for live streaming.
- Added two projectors and screens for services.
- Added two new microphones and stands for the piano and harpsichord for live streaming.
- Added one large screen TV for choir to see the services.
- Added an AC circuit for camera and TV on West side of sanctuary.
- Added a new digital sound board for services and live streaming.
- Added four new speakers for better sound in the Sanctuary.
- Replaced 800' of drip line for west side of parking lot by school and the back of Barrett Park.
- Added five water meters to sprinkler system to save on sewer billing.
- Took out a tree stump and repaired paver walkway in the Memorial Garden.
- Replaced water pump to boiler system due to it burning out because of power spikes.
- Replaced fan motor near sanctuary due to its burning out.
- Assembled a committee to see how best to redo Barrett Park and improve the area.
- Worked on and are currently getting three bids to repair the flat roof over the offices and the roof over the kitchen and store room.

As you can see, it was a pretty busy year for the Building & Grounds Committee in 2021, and we expect another busy year ahead in 2022.

Below are a few projects that we will be working on this year.

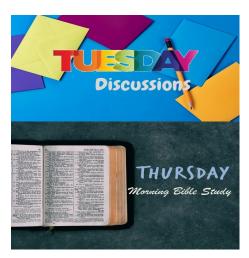
- Paint the Men's Bathroom near the Clawson Library.
- Redesign and improve Barrett Park.
- Repair Kitchen and store room roof and flat roof over the offices.
- Get bids to repave the parking lot and adding parking lot lighting.
- Hire a cleaning company to maintain the church building.
- Tear down and replace wooden shed due to vandalism.

Adult Education classes were offered on Zoom, some on Tuesday afternoons and some on Thursday afternoons: Selected parables; a study of the Minor Prophets; The Lord's Prayer; Lent study drawing on Les Misérables; Afternoon devotional times led by congregational members in Lent; a study on Presbyterian Creeds and Confessions interspersed with movies; a study of the Apocrypha; Post-Resurrection Appearances of Jesus: The Crusades; a study of the Trinity; a study of the history of Israel and Palestine as we seek to understand the current Israeli-Palestinian situation. This class read and discussed The Lemon Tree by Sandy Tolen and is continuing this study as we have moved into 2022.

Last year's **Souper Bowl of Caring** was 2/7/21. With many thanks to the congregation for your generosity, St. John's was able to collect \$2,195.00, donating it equally between Northern Nevada Food Bank and Eddy House.





Vacation Bible School:

The committee had much discussion but decided, because of Covid, we could not offer an in-person, mostly

inside program. Instead, we re-designed an older VBS program, Baobab Blast, to offer an at home approach with a few twists from our traditional program: we resourced one new day each week, so this year VBS was a 5-week program. Participating families picked up materials they would need on the preceding Saturday mornings or Sunday afternoons. Many resources were available online but items like snack, a music video, song sheets, science materials, etc., were in the take home bags which were picked up each weekend. New material was posted the website each successive week on Wednesdays. A team prepared the bags to be picked up on the weekend each

Friday. The areas covered each day: the Bible Story; Snack; games for the SJCC class which participated and yoga routines for athome students, along with a Mindfulness Moment each day; Music; Crafts; Science; and a local Mission project. Using the African Savannah as a backdrop, a weekly get acquainted page for five African animals was included. We finished our time together with a picnic on July 14.





On October 28, we offered our traditional **Trunk or Treat**. The congregation was hugely important in this effort, both in turning up with decorated trunks in the morning event cooperatively with SJCC, the church Trunk or Treat event at 4 PM, and in supplying a very generous number of treats for the children to receive at each car.





ADVENTure Night took place on November 21 (the Sunday before Advent begins) from 3:00 pm—5:00 pm. We had almost 100% participation from all church groups and committees in preparing craft tables. Because attendance of those wishing to get crafty was low, we are re-evaluating our publicity for 2022 and contemplating a name change. The committee is most grateful to all the folks who were ready with supplies and leadership at 2021 ADVENTure Night.

The Christian Education (CE) Committee and Worship Committee have begun planning together ways to welcome young families with children into the worship space on Sunday mornings.

The CE Committee continues to work together with the staff and children of SJCC to provide a Christian values weekly.

If you have an interest in working with the Christian Education Committee as we begin our new year of planning and programming, we will welcome your participation!

We thank each of you for your support and this chance to use our spiritual gifts of hospitality and nurture.

Because of the Covid Pandemic, we were unable to host most of our usual events. We all hope to begin hosting these events in 2022!!





The Mission Committee aims to ensure that St. John's Presbyterian Church is an active participant in local mission projects in our Northern Nevada community, international projects, and the ministries supported by the Presbyterian Church (U.S.A). This past year we continued to build upon the groundwork established in prior years, as the Missions Committee added a new moderator, Nancy Lim, lost a few committee members, and added a new member, Ron Scovill. We also strived to communicate our activities and accomplishments throughout the year to the congregation by frequent presentations during worship services, articles in the Carillon and the Missions blog which is accessed from the church website, and by emails. Our hope is to expand these efforts in 2022, identify organizations to which St. John's can make a meaningful contribution, both monetarily and by active participation, and grow the committee with new members.

National and International Mission

St. John's is a strong supporter of the ministries of the larger national and regional Presbyterian Church organizations. The Missions Committee contributed \$18,000 for shared mission support in 2021 which funds the overall mission and ministry of our Presbytery, our Synod, and the General Assembly Mission Council. In addition, the per capita apportion (\$10,101.60 for 2021) came from the Mission General Funds. This per capita apportion is based upon the membership of St. John's and is shared among the administrative bodies of the Presbyterian Church (U.S.A.), our Synod, and our Presbytery.



St. John's also collects additional donations from the congregation for three special Presbyterian Church (U.S.A.) offerings throughout the year. The first special offering is the One Great Hour of Sharing (OGHS) on Palm/Easter Sunday. Donations to the One Great OGHS are divided between three programs of the national Presbyterian Church (U.S.A). the Presbyterian Disaster Assistance (PDA), the Self Development of People, and the Presbyterian Hunger Program.









This past year St. John's raised \$8.849.90 for OGHS, which included contributions from St. John's Children's Center. The second special offering is the Pentecost Offering which helps the church encourage, develop, and support youth and at-risk children. This year St. John's raised \$2,975.00 for the Pentecost Offering. 40% of the Pentecost Offering was retained to make an impact in the lives of young people in our own community. The Missions Committee chose to designate Project 150 (see page 12) as the local recipient of the 40% portion (\$1,190). The remaining 60% (\$1,795) was sent to the Presbyterian Church (U.S.A.), to support youth ministries of the Presbyterian Mission Agency. The third special offering is the Christmas Joy Offering, which raised \$2,895 in 2021, and provides financial support to church workers and their families and education and leadership development for Presbyterian-related schools and colleges.

In the fall of 2021, St. John's generously responded to multiple disasters in our community and around the world. Wildfires, an earthquake in Haiti, floods in the U.S. and abroad, drought, and the pandemic all seemed to be happening at once. The Missions committee raised awareness for an additional collection for the PDA program of the Presbyterian Church (U.S.A.) which is uniquely capable of responding to disasters quickly. Through this effort, St. John's donated \$1,300 to the PDA.



A final piece of the National and International missions of St. John's is the Presbyterian sponsored organization called Frontera de Cristo. This organization, which operates in towns near the Arizona/Mexico border, offers assistance to families fleeing violence and poverty and strives to build relationships between people of different beliefs who live along the border. St. John's contributed \$6,000 to Frontero de Cristo in 2021.

The Missions Committee chose Project 150 as the local recipient of a special fund raiser in the spring of 2021. Project 150 is a nonprofit located near Reno High School which serves displaced, disadvantaged, and homeless high school youth in Northern Nevada. They operate a boutique where needy students can "shop" for food, clothing, shoes, and toiletries. St. John's donated 28 gift cards to be used as graduation gifts and 4 large stuffed bags of toiletries at the end of May. Monetary donations to Project 150 (which includes the 40% share of the Pentecost Offering) totaled \$3,010. Approximately half this amount was sent in June to Project 150 to be used for graduation gift cards, and the other half in November for Christmas gift cards.

Another local charity that the Missions Committee has donated to in the past is the Kid's Café of the Northern Nevada Food Bank. Kids Cafe is a program that offers free meals to children after school and throughout the summer while they are out of school. We chose to highlight this worthy program at Thanksgiving, and St. John's contributed \$700 to Kid's Café.



The Mission Committee strives to support the many independent projects undertaken by other members and committees of St. John's. These include collections of items throughout the year and Thanksgiving meals for the residents of Sierra Manor, the backpack project for local schools in the fall (\$961 from Mission), the Crop Walk for Church World Services in October (\$2,747.22 contributed by St. John's members), Trunk or Treat, stockings and Christmas stockings for Catholic Charities.



Jesus calls us to love our neighbors. The Mission Committee helps St. John's answer this call as best we can, using the talents and resources we are blessed with. We could not do our work without the very generous support of our congregation.

The Multi Media Committee is St. John's newest committee. The committee was founded in November 2021. It was created in response to the current pandemic due to the need to adopt new strategies and innovations to deliver the message of Jesus Christ through various forms of media and technology.





Committee Responsibilities:

- Oversee/Manage the church website
- Oversee/Manage social media accounts/platforms
- Operate/Manage the sound system and streaming equipment
- Produce/Maintain the TV display in the Narthex
- Create, update, and distribute the church videos



Among the most significant responsibilities is the operation of the sound system and streaming equipment. Due to the ongoing pandemic, the need to allow worship services to be streamed and viewed remotely was dire.

Zoom was first used as the tool to fulfill this need, but it had limitations. Most notably, the audio and camera. (It did offer a nice way for viewers to chat and see each other after the service. The Committee may look to see if there is a way to include this feature).





It was eventually decided that the streaming platform of choice would be <u>christianworldmedia.com</u>, a streaming service that specializes in streaming Church worship services. Equipment for the camera and microphone was purchased and installed. Eventually, the first livestream service was broadcasted in June 2021.

There is so much potential with the use of the cameras, projectors, and tools that the Committee will learn to better the livestreaming. This includes the continued collaboration with church staff and other committees to meet our goals. We look forward to what this year brings!

The committee is aiming to better the website and the church's presence with social media. The committee has taken on the responsibility of ensuring that Church's Welcoming video is updated and accessible. The Committee will also manage the display screen in the Narthex. Both tasks were originally part of the Welcoming Committee. As such, the Multi Media Committee will work closely with them.

To conclude, once again thank you to everyone for your help and support in getting the livestream going! The Committee may just be getting started, but we look forward to better serving the Church and community to further spread the Word and love of Jesus Christ through innovation, technology, and media!

I would like to give a big shout out to the Multi Media Committee Members and supporting ex-officio Church Staff who were so willing to jump on board.

The Session Manual states that the Personnel Committee is responsible for all matters regarding the staff of St. John's Presbyterian Church. We feel that our responsibilities are best carried out by advocating for fair salaries, better equipment and ensuring clear job descriptions and responsibilities so staff is content, can operate efficiently and do what is reasonably expected of them.

Covid-19 and its variants have continued to make things more difficult for all of us and the Committee was no exception. Our best

work is enhanced by face to face meetings and much of that has ceased in an attempt to avoid the spread of the virus and potential infections. Despite those limitations and the lack of volunteers willing to serve on the Committee, we managed to complete most of our tasks in a timely manner.

The contracts of the Music Director and Organist were successfully renegotiated in 2021 during the period the Church was closed and again when the Church reopened with "in person" services and a return of singing with the choir. We all know and appreciate the music program at St. John's and how important it has been to making Sunday services as good as could be expected in a very difficult environment. Of course, Maria Winchester and others have worked very hard to ensure our zoom and subsequent "streaming" Sunday services were as close to being in the church as possible. There were glitches, but the media services have become better as the staff has become used to the operations of the equipment. Pastor Helen has been most instrumental in keeping the Congregation united and in providing the Congregation with excellent direction for our lives with her inspiring sermons.

Evaluations were conducted for the staff by Personnel with substantial input from the Finance Committee as to availability of funds. It was not lost on all that 2021 was a tough year with shortages of most everything and soaring inflation. With the foregoing input, Personnel recommended to Session a 5.9 percent bonus for staff (basically a cost of living increase) plus an additional \$2000 dollar for Pastor Helen for a total increase of 8.48 percent. Maria Winchester's position was changed to "salaried" and an additional increase of 5.9 percent as a result of her media work and changes in her job description.

Personnel has been working with our Sexton, Gerson Orellana, in an effort to modify his duties to accommodate a return to "in person" Sunday services, but no agreement has been reached. We expect a resolution in February, but there will likely be a need for contract services for certain functions that were terminated when the Church was closed.

I want to express my appreciation and gratitude to those who served this past year on the Committee...Martha Galloway, David Stover, Anne Sigurdson and Carolyn Williamson...who committed their time and talents to our mission. Their commitment is reflective of their commitment to His Church and dedication to Him.

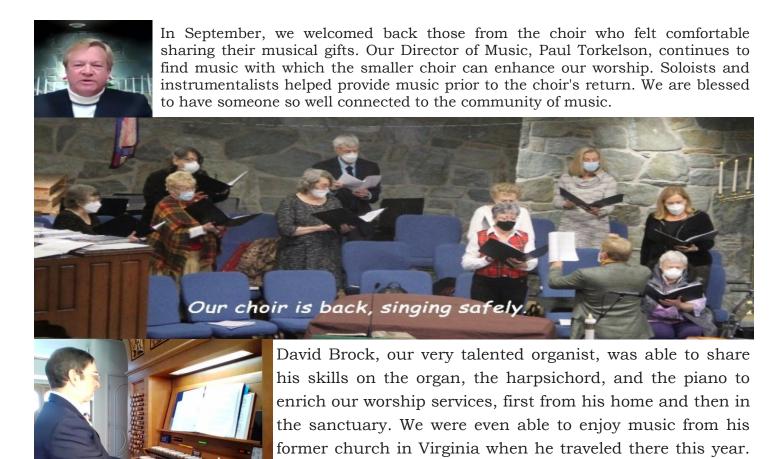

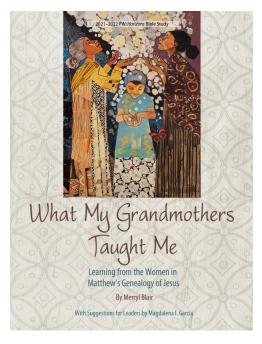
It has been a year of challenges for the worship committee. In December we lost one of our most valued members, Ralph Voss.

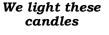

terested in are as follows:

January—our PPP loan was forgiven in the amount of \$54,900.

February—paid Per Capita at \$46.00 per member—\$10,102. Invested \$150,000 in the short-term Synod Account and \$100,000 to the long- term Synod Account to get a better return for our funds.

March—Moana Nursery was paid \$31,123 at the completion of the Water Meter Project.

April—We purchased new computers for Helen and Maria. Received \$8,294 for One Great Hour of Sharing

June—paid \$1,600 for Annual Financial Review. Paid \$1,200 to tune and repair Piano and Harpsichord. Gave \$1,690 to Project 150 and \$2,975 for Pentecost. Received \$10,000 Grant from Nevada Presbytery for new Sound System.

August—Paid \$6,962 for new Microphones for Sound System,

September—Purchased new Office chairs.

October—\$5,000 from Carillon Fund to Barrett Park Fund. Sent &1,250 to Synod for Disaster Relief. Donated \$1,500 to Project 150. \$1,670 was transferred to New Additional Worship. \$5,000 of General Fund allocated for Additional Worship Service. \$1,400 from Praise Band Leader allocated for Additional Worship.

November—Spent \$570 for Thanksgiving meals at Sierra Manor.

Wow! 2021—another Covid year! We at St. John's have survived and rejoice that we are beginning to return to not only how we are used to worshipping but also worshipping with members and friends via live streaming. We look forward to further reductions of Covid restrictions when even more of us can enjoy worshipping together in person.

We began 2021 with a cash balance of \$43,278 and ended the year with a \$56,734 balance. We were able to meet our budget without using any of the Unrestricted Funds generated from Endowment Fund interest. Once again, we thank you for your very generous giving, including three \$25,000 gifts received this year. In addition, we thank our various committees for keeping their expenses low again this year. Your 2021 gifts to God's work through St. John's Presbyterian Church allowed us to continue with on-going programs as well as begin others, including our new 8:30 am early service.

There were two major Capital Improvement expenses this year.

- 1. \$31,125 was spent from the Capital Improvement Fund for installing Badger meters on our irrigation lines to eliminate sewer charges for water used for irrigation.
- 2. \$35,142 was spent to install a new, greatly improved sound system and equipment needed to go to full Live Streaming. See Building & Grounds Committee report regarding this expense. Special gifts as well as B&G Endowment and Unrestricted Funds were used for this expense.

Our on-line giving continues to be used by several of our members and friends, and we anticipate it will continue to grow as more people learn about it and find it convenient.

This year's Stewardship Program resulted in pledges for 2022 amounting to \$224,760 with about \$30,000 more anticipated. Together, this will be an increase over last year. We thank all of you for your continued, strong financial support. If you have not sent in your Estimate of Giving for 2022, it is not too late to do so. You can go to the St. John's website and click on Estimate of Giving and the program will "walk you through the process." Your confidentiality, of course, will be maintained. If you would rather, you can contact the church office at 826-0990 or email Liz Salas, Financial Secretary, at liz@stjohnschurch.org to have a form mailed to you.

We do need every member's help in the area of Per Capita giving. Not familiar with what Per Capita is and why we pay it? St. John's Presbyterian Church is a connectional church with work done, not only here at SJ's but also statewide, regionally, and nationally. In 2021, our Per Capita giving was \$4,025; however, that was only 40% of the \$10,102 we were assessed by Presbytery for our share. The remaining \$6,177 was paid out of our general fund in February in order to take advantage of the substantial discount offered. If you have not already sent in your Per Capita amount for this year (\$46 per member, not household), please do so as soon as possible. Thank you for helping with this separate expense each year.

I would like to thank our Financial Secretary, Liz Salas, for the excellent job she does throughout the year maintaining St. John's financial records, providing reports and information to all committees and Session, and monitoring our whole financial picture. We are very fortunate to have someone of her caliber. Thank you, Liz.

Thank you to all of you at St. John's for all your support of the work here at our church. It is a pleasure to be part of this work.
